ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Bake Kepo, C/o Hotel Arun Subansiri, 'O' Point Ianagar, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, Govt. of A.P., Directorate of Elementary Education, ESS-Sector, Itanagar, Arunachal Pradesh Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 26/06/2023 regarding **TGT Trained Graduate Teacher, Primary Teacher Trained Graduate Teacher and RR of Primary Teacher.**

The 1st hearing is held today on 30th January, 2024 as scheduled. Shri Kadhing Perme, the PIO-cum-JDEE, Govt. of A.P., Directorate of Elementary Education, ESS-Sector, Itanagar, Arunachal Pradesh Pradesh alone is present. The Appellant Shri Bake Kepo is absent. The PIO has submitted that the information sought for are kept ready to be furnished. The PIO also informed that few days back the Appellant visited the office of the PIO, the appellant was provided with the information but the Appellant did not collect the information related to the appointment of TGT, PGT of 2014 and recruitment rules. The information were brought during the hearing in the court room to be furnished to the appellant but the appellant was absent so could not be furnished.

The Appellant is directed to visit the office of the PIO and collect information within fifteen days from the date of issue of this order and make a list of information if any left out and intimate to the PIO and to the commission within fifteen days from the date of issue of this order, failing which the case shall be disposed of. The PIO is directed to furnish complete, correct and authenticated information to the appellant. If any information are not available the PIO must give justifiable reasons in writing to the appellant and intimate to the Commission within seven days after the receipt of list from the appellant, failing which penal action under RTI Act shall be initiate against the PIO.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

The next date of hearing is fixed on 23rd April, 2024 (Tuesday) at 1030 hrs.

Therefore, Shri Kadhing Perme, the PIO-cum-JDEE, Govt. of A.P., Directorate of Elementary Education, ESS-Sector, Itanagar, Arunachal Pradesh Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
