**ORDER/SUMMON**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri John Tara Bakey for non-furnishing of below mentioned information by the PIO, o/o the Deputy Commissioner, Yachuli, Keyi Panyor District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 19.05.2025

**A) Particulars of Information:** - Gun License issued since 30.07.2017 to till date.

**B) Details of information required:**

1. Furnish the copy of name of the applicants for issuing of Gun License from 30.07.2017 to till date.
2. Furnish the copies of total numbers of Gun Licenses issued to the applicants from 30.07.2017 to till date.
3. Furnish the copies of Gun Licenses number, if any gun licenses from 30.07.2017 to till date.
4. Furnish a copy of any revocation order of issued of gun license banned by previous, if so.
5. Furnish copies of purchase cash Memo of the licenses holder deposited at DC, office.

**For the period from:** 30.07.2017 to till date.

This appeal was listed for 2(two) times on 24.09.25 and 29.10.2025. But none of the parties appeared on 24.09.25 despite summons notices but on 29.10.2025, the appellant, Shri John Tara Bakey appeared and the PIO, o/o DC, Keyi Panyor, Yachuli was represented by Shri Taba Tahin, Statistical Officer and Shri Harshdeep, under trainee C.O, o/o DC, Keyi Panyor, Yachuli.

This Commission, after hearing the representatives of the PIO who submitted , inter alia, that that no new gun license has so far been issued by the o/o the DC, Keyi Panyor District which was constituted in the year 2023 and also admitted that applications for gun license were received by the District administration, held that the information /documents sought for by the appellant were not exempted under any of the exemption clauses under section 8(1) of the RTI Act, 2005 and hence, the PIO was directed to get the list containing the names of applicants for gun license typed from the register and furnish the same to the appellant.

The PIO was also directed to furnish the information/replies to other queries point-wise in tabular form with specific reasons within 1(one) month from the date of receipt of the order dt.29.10.2025.

The Commission is, however, in receipt of letter dt.25.11.25 from the appellant, complaining thereby that the PIO has not complied with this Commission's aforesaid order and hence demanded penal action against the PIO.

In order that this Commission is not constrained to invoke the penal provisions under section 20 of the RTI Act, 2005 for non-compliance of its order, the PIO is directed to furnish the requested information as directed earlier within 3(three) weeks from the date of receipt of this order and report the compliance thereof on 24.12.2025, the next date of hearing.
