WARNING SUMMON

WHEREAS, in connection with the APIC-No. 405/2023, your personal appearance is required before the Commission on **05th February, 2026 at 10:30 AM**. The 4th hearing held on 30th Sept '2025, related the APIC-405/2023 (Appeal). The appellant Shri Kabak pavitro, found absent during the hearing without intimating the reason for his inability to attend the hearing.

The PIO-cum- EE (PWD) Raga Division, also found absent without intimating to the Commission the reason for their inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides public duties, also has to attend the Court when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

This case has been transferred from the Court of the HHSIC Shri Dani Gamboo who had taken 1st hearing on 29/09/2023, 2nd hearing on 8/12/2023 & 3rd hearing on 05/04/2024.

In the 4th Court hearing which is today both the parties are absent without intimating the reason of their absence to the Commission. In the absence of both the parties the case was not heard today.

Under the above circumstances, the Commission hereby orders;

To send summons to the PIO-cum EE PWD Raga Divison Kamle District, to be present in the next date of hearing without fail, failing which necessary action will be initiated against him as per the provisions of RTI Act 2005.

The Appellant Shri Kabak Pavitro, to be present in the next date of hearing without fail, **failing which this appeal will be heard and determined ex-parte.**
