**ORDER/SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Pisa Tapam for non-furnishing of 22(twenty two) point information in respect of the following six roads under VVP: 2023-24 by the PIO, o/o the E.E (RWD), Layang Yangte Division, Kurung Kumey District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 26.06.2025.

1. L021-Road from Nyolo to Buhan
2. L027-Rd from 2.5 Km Pt of Koloriang-Tabumhard to Sollung Tapin
3. L022 Road from Buyang to Chimpu
4. L023-Road from Buyang to Degging-1
5. L-028 Road from Buyang to Tate (Raktepu)
6. L026 - Road from Tabumha to Naji Bobok
7. L024 Road from BRTF road to Kachanjane
8. L025-Road from Nijubobok to Kiodhriang

This appeal is listed for hearing for the 2<sup>nd</sup> time today 22.04.2026 the first time being on 06.03.2026 wherein Er. Shri Yangbiu Loka, AE-cum-APIO was present in person while the appellant, Pisa Tapam attended through VC.

This Commission, after hearing the parties, more particularly, the APIO who submitted that the documents pertaining to this appeal are with the Koloriang Division as the particulars of schemes mentioned in the RTI application of the appellant comes under the jurisdiction of PIO, o/o the RWD, Koloriang Division and also upon perusing letter dt. 3<sup>rd</sup> February, 2026 requesting this Commission to transfer the appeal in question to the PIO, o/o the EE, RWD Koloriang Division, deemed it appropriate to hear the PIOs of both the Laaying Yangte and the Koloriang Divisions and decide as to whose office shall furnish the requested information/documents to the appellant.

The PIO, o/o the E.E(RWD), Laying Yangte Division and the PIO o/o the E.E (RWD), Koloriang Division Koloriang Division were, therefore, directed to be present in the next hearing fixed today on 22<sup>th</sup> April, 2026 with records / evidence of handing over and taking over of the charges of records/documents pertaining to schemes falling under the jurisdiction Koloriang Division.

This Commission, however, notices that none of the PIOs appeared today in view whereof, the hearing of this appeal is adjourned to 22nd May, 2026 on which date the PIOs shall be present without fail so as not to compel this Commission to invoke the penal provisions of RTI Act, 2005.
