An Appeal Case U/S 19(3) of RTI Act, 2005.
Vide Case No. APIC-191/2024

Shri Dawa Tsering -V/S- PIO-Cum-DFO, Bomdila, West Kameng District

ORDER

The 5th hearing held on 8th April, 2025 related to the APIC No-191/2024. The Appellant Shri Dawa Tsering is present through online mode during the hearing. The PIO though not present represented by Shri Gollo Nera, I/c APIO, Bomdila Forest Division, Bomdila, with an authorization letter from the PIO, during the hearing before the Commission.

Heard the Appellant:

The Appellant stated before the Commission that he has been given in-complete information(s) from the office of the PIO.

Heard the representative of the PIO;

The representative of the PIO stated before the Commission that the information(s) pertaining to Serial Nos. 5 & 6 of the Form-A application of the Appellant have been asked from the dealing assistant, office of the DFO, Dirang to provide the information(s) so as to make it available to the Appellant. In Part-II- of the Form-A of the Appellant, there is no VFR in Dirang Range and so providing MoU and utilization Certificates do not arise in Dirang Range. In the Part-III- of the Form-A of the Appellant, the representative of the PIO submitted that no works were carried out in Dirang Range under the GIM Scheme, so the information(s) could not be provided to the Appellant.

The Commission observes;

Whatever, the information(s) available with the PIO's office pertaining to works executed under the Dirang Range be provided to the Appellant.

After hearing the representative of the PIO and going through Form-A application of the Appellant;

The Commission hereby orders;

- (i) The PIO to provide the copies of Sanction order, the copies of Utilization Certificate (UC) and the copies of Geo-tag pertaining to the schemes implemented under the Dirang Range, under CAMPA, under CA & ANR and GIM to the Appellant from 2019 to 2023.

- (ii) After due consideration the commission has amended the Form-A application of the Appellant confining it to the Sanction order, U/C and Geo-tag under CAMPA, CA & ANR, name of contractors under NPV Scheme, copies of payment details, counter foils made in respect of Dirang Range under GIM Scheme from 2019 to 2023 for the works implemented in Dirang Range only, information(s) be provided to the appellant on or before the next date of hearing.
- (iii) Notice need not be issued to both the parties as they are present during the hearing before the Commission.

The next date of hearing be fixed on 24th June, 2025' at 2:30 PM (Evening).


