Summon Notice.

WHEREAS, the 2nd hearing was held on **29th January, 2024** related to the APIC No-965/2023 (Appeal). Both the parties found absent.

WHEREAS, during last hearing on dated 18/12/2023, the appellant intimated to the Commission that till date PIO failed to furnish the information as sought by the appellant in his form 'A' application.

WHEREAS, After hearing from the appellant, the Commission directed to issue summon notice to the PIO to appear in person before the Commission in the next date of hearing i.e., on **29/01/2029** and also directed to furnish all the information correct, clear and authentic to the appellant on or before next date of hearing. But the PIO failed to comply the direction of the Commission.

WHEREAS, The Commission viewed seriously on the reluctant attitude of the PIO by disobeying the direction/order of the Commission, which directed to him in the last hearing dated on 18/12/2023 and also consecutively twice he remained absent from the hearing dated on 18/12/2023 & 29/01/2024.

WHEREAS, therefore, the Commission directed to issue warning summon notice to PIO for his appear in person before the Commission in next date of hearing and also directed to furnish all the information correct, clear and authentic with proper CTC with seal & signature of the PIO as sought by the appellant in his form 'A' application on or before next date of the hearing. Failing which, necessary action shall be initiated against the PIO as per the RTI Act, 2005.

WHEREAS, the appellant also remained absent from the hearing inspite of the clear direction of the Commission. So, the Commission directed to issue last warning summon notice to the appellant to appear in person before the Commission in the next date of hearing. Failing which his appeal No. APIC-965/2023 shall be decided as ex-parte and dispose off.

The Commission fixed next date of hearing on **1st May, 2024 at 2 PM.**
