SUMMON

WHEREAS, in connection with the **APIC-No. 769/2025**, your personal appearances required before the Commission on **19th May 2026 at 02:30 PM**. The 1st hearing held on **26th February' 2026'**. The Appellant Mamu Sono is present through online mode during the hearing before the Commission.

The PIO-cum-EE, PWD, Seppa Division, East Kameng District, Govt. of Arunachal Pradesh found absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

Heard the Appellant;

The Appellant stated that he has not been furnished any information from the office of the PIO till today.

The Commission observes;

The PIO is absent despite notice served to him through WT message on 8th day of December' 2025 to be present today.

In the absence of the PIO the case is adjourned and posted to another date.

After hearing the Appellant and going through the Form-A application of the Appellant **the Commission hereby order as follows;**

- i) The **Summons** be issued to the PIO to be present in the next date of hearing in person or through online mode without fail, failing which appropriate action will be initiated against the PIO as per the provisions of the RTI, Act, 2005.
- ii) The Appellant to be present in the next date of hearing in person or through online mode without fail, failing which this appeal will be heard and determined ex-parte.

- iii) Notice for next date of hearing need not be issued to the Appellant as he is present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 19th day of May' 2026 at 2:30 PM (Evening).
