SUMMON

WHEREAS, in connection with the APIC-No. 355/2025, your personal appearance is required before the Commission on **19th March, 2026 at 10:30 AM**. The 1st hearing held on 6th November' 2025. The Appellant Shri Tamchi Gungte found absent during the hearing and PIO-cum EE (RWD) Namsai Division, is also absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

The Commission seriously viewed the absence of both the parties and hereby orders;

- i) To **issue summon** to the PIO to appear in person or through online mode before the Commission in the next date of hearing. **Failing which necessary action shall be initiated against the PIO as per RTI Act 2005.**
- ii) To **issue summon** to the Appellant to appear in person or through online mode before the Commission in the next date of hearing. **Failing which his appeal shall be decided ex-parte.**

Due to absence of both the parties, the Commission could not proceed the hearing of the appeal.

The Commission ordered;

The next date of hearing be fixed on 19th March' 2026 at 10:30 AM.
