**SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu for non-furnishing of below mentioned information by the PIO, o/o Executive Engineer (PHE & WS), Hawaii Division, Anjaw District Arunachal Pradesh as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 03.03.2025.

**a) Particulars of information:** To furnish Information against the allocation of fund under the funding head of JJM for expenditure of support activities and water quality monitoring & surveillance for the year 2020-21 & 2021-22 as per RTI documents obtained from CEZ-cum-Mission Director Jal Jeevan Mission (JJM) may be annexure herewith Form-A. In the year 2020-21 & 2021-22 i.e Rs. 36.77+ Rs.141.07= Rs. 177.84 ( one crore seventy seven lakhs eighty four thousand).

**b) Details of information Required:**

1. Furnish the Technical Sanction (TS) copy/Sanction order copy/DPR/Work Order/Supply Order Copy/LOC copy with details of Payment like Xerox copy of Cheque Leaf/demand draft/banker Cheque/pay in slip for NEFT/RTGS as per name of work Order/Supply Order/Sanction Order wise and mention the Name of Person who Received the bill Payment with their Contact number against above Specified Amount.
2. Give the name of Work/Scheme List with Sanction amount.
3. Give the Money Receipt list of contractor bill Payment with their name & mobile number who received the bill payment.
4. Give the details of billing sheet/Scheme sheets copy/details of MB Records/Cashbook Statement in work list wise.
5. Give name of contractors/Firm/Enterprise/NGO/CBO/Xerox copy of Firm with Proprietor name & mobile number in work wise.
6. Furnish the Estimates and quotation of all capital Expenditure and equipment/description of work/Quantity/Rate/amount for materials/items.
7. Furnish the Bank account number of village Water Sanitation Committees (vwsc) of every GPC Segment/CD block.

8. Give the name of Chairman and Member Secretary of Village Water Sanitation Committee(VWSC) of every GPC Segment, who jointly Operate the Bank account with their contact number in village/Block wise.
  9. Give the copy of Money deposited treasury challan to Govt. account against GST by department in work List wise.
  10. Give the NOC Copy of ZPC/ZPM/GPC/GPM/Gaon Bura/Gaon Buris of Concern Villages/Blocks with their Counter Sign with Seal and Contact Number,
  11. Give the name of Officers & Officials who Executed the works.
  12. All the information should be furnish in GPC/CD Block wise or year wise.
  13. Give the Xerox copy of trading licence / letter ..... of firm/ Pancard of proprietor/ bill & challan etc.
- c) Period from which information asked for: 2019-2024.
