WARNING SUMMON

WHEREAS, in connection with the **APIC-No. 34/2026**, your personal appearance is required before the Commission on **1st October, 2026 at 02:30 PM**. The 2nd hearing held on **23rd July' 2026**. The Appellant Shri Tamchi Gungte is absent without reporting the reason for his absence during the hearing before the Commission.

The PIO-cum-Executive Engineer (EE), PHE & WS, Hawaii Division, Anjaw District, Govt. of Arunachal Pradesh, found absent consecutively for the second time without reporting the reason for his absence to the Commission despite hearing notice sent to him from the Arunachal Pradesh Information Commission (APIC) on 17.02.2026 and 12.05.2026.

In the absence of both the parties the hearing is adjourned with the following orders;

- i) Issue **Bailable Warrant of Arrest** against the PIO-cum-Executive Engineer, PHE & WS, Hawaii Division, Anjaw District, for securing his attendance in the Third Hearing of this appeal, which is fixed on 1st day of October' 2026 at 10:30 AM.
- ii) Issue order to the Officer-In-Charge, Hawaii Police Station, Anjaw District, for executing the **Bailable Warrant of Arrest** and to return the same and produce the errant PIO on the next date of hearing of this appeal which is fixed on **01.10.2026, at 10:30 AM, without fail**, before this court.
- iii) The copy of this **Bailable Warrant of Arrest** be served to the Superintendent of Police, Anjaw District for compliance.
- iv) The copy of this **Bailable Warrant of Arrest** be served to the Deputy Commissioner, Anjaw District for information.
- v) The Appellant to be present in the next date of hearing without fail, failing which the Commission will hear and determine this appeal ex-parte.
- vi) Notice for the next date of hearing be served to both the parties.

The Commission hereby orders;

The next date of hearing be fixed on 1st day of October' 2026 at 10:30 AM (Morning).
