### ORDER

The 2<sup>nd</sup> hearing held on 13<sup>th</sup> November' 2025 related to the APIC No-139/2025.

The Appellant Miss Bengia Mama is present.

The PIO-cum-EE, PWD, Basar Division, Leparada District, Govt. of Arunachal Pradesh is represented by Shri Kayi Gadi, Assistant Engineer, Tirbin Sub-Division, PWD, AP, Leparada Distirct, during the hearing before the Commission.

#### **Heard the Appellant;**

The Appellant informed that after the last order of the Arunachal Pradesh Information Commission (APIC) court on 05.08.2025, the information pertaining to Serial Nos. 1, 2, 4, 7, 8, 9 and 10 for the year 2018-19 are yet to be provided by the PIO to the Appellant.

#### **Heard the representative of the PIO;**

In the light of the above the Commission hereby orders;

- i) The Appellant to verify the information and to let the Commission know that She has received the complete information from the PIO or not on or before the next date of hearing and to be present in the next date of hearing without fail, failing which the Commission will assume that the information have been provided to her completely and so will dispose this instant appeal.
- ii) The PIO to be present in the next date of hearing without fail.

iii) Notice need not be issued to the Appellant as he is present during the hearing before the Commission.

**The next date of hearing be fixed on 19<sup>th</sup> day of March' 2026' at 10:30 AM (Morning).**
