SUMMON

WHEREAS, in connection with the APIC-No. 636/2025, your personal appearance is required before the Commission on **2 April, 2026 at 10:30 AM**. The 1st hearing held on **27 November 2025**, related to the APIC No-636/2025. The Appellant Shri Kumar Tayam absent. The PIO also found absent without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the RTI, Act, 2005, which is a statutory duty binding upon the PIO.

Due to absence of both the parties, hearing of the Appeal could not proceed. The Commission seriously viewed the absence of the PIO and orders;

- i) To issue **summons** to the PIO to appear in person or through online mode before the Commission in the next date of hearing. ***Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act 2005.***
- ii) **To issue summons** to the Appellant to appear in person or through online mode before the Commission in the next date of hearing. ***Failing which his appeal shall be decided ex-parte.***
- iii) The PIO to provide all the information(s) to the Appellant on or before next date of hearing as sought in the form 'A' Application of the Appellant.
- iv) Next date of hearing be intimated to both the parties.

The Commission ordered;

The next date of hearing be fixed on 2nd April 2026 at 10:30 AM (Morning)
