### ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu for non-furnishing of below mentioned information by the PIO, o/o CF/Field Director, Namdapa National Park & TR Miao, Changlang Distt., Arunachal Pradesh, as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 09.10.2024.

a) **Particulars of information:** All the Relevant Information against the Released of Fund amounting of Rs. 266.73952 lakhs of LOC for the month of March ,2024 to DFO Account no. 31673740392 for proper implement of the items under CA, WLM & NPV'' components of the State CAMPA AOP Vol-I & II during: 2023-2024 under Department of Environment & Forest & Climate Change as per Sanction order.

b) **Details of information Required:**

1. Technical Sanction Order/DPR/Estimate/UC.
2. Name of work list with Geo-tag Report.
3. the list of all the Work Order/Supply order copy with details of payment like cheque book counterfoil/leaf/demand draft/banker cheque/deposited challan and PFMS Transaction details as according to the amount mentioned in work order/sanction order/First & final copy/MB;
4. the description of work/Supply work/Quantity/rate/pr nos/amount with cash memo/money receipt of every material;
5. Xerox copy of all the firms/Trading License of Contractors/Enterprise with its Bank account number/Cheque book counterfoil/leaf/challan of deposited Amount against GST/Royalty to Govt Account by OFO/RFO/Firms Enterprise.
6. NOC copy of Head Gaon Bura/Gaon Bura and Gaon Buris from concern Villages.
7. copy of Legal Agreement between Contractor/Land owner and Department for carry out work through Magistrate counter sign and HGB/GB counter sign with seal.
8. Name of contractor or What Firm/Enterprise Owner and Proprietor is to RFO/DFO or what connection to them?



9. Give Total Area Square of Land with Longitude and Latitude of Area/Exact Location of work Area with LPC Copy.
10. Money Receipt /Cash Memo/Challan of all the items/works/Contractors/firms.
11. Details of Payment list with Money Receipt of all the contractors/firms/Enterprise /cash Book Statement.
12. Account Statement of DFO or Bank Account Statement of Range Forest: Officer (RFO) with its account Number Give the name of officer holding the DDFO Power with their sign and seal.
13. Name of Officers and Officials who Executed/Handled the Aforesaid work/ — Prepared DPR/First & Final Bill and made payment. Give the name of officer who is holding the DDO power with the signature and Seal.
14. Govt. Notification/Cabinet passed Order copy for RFO to prepare DPR/Estimate/First & Final Bill of works/made payment without Engineers.
15. All the details of Fund/Amount Transaction to RFO Account from DFO Account.
16. Measurement Book (MB) with page number/Hand Receipt and Payees Name;
17. Mentioned various deduction of amount as percent from Contractor bill payment by RFO/DFO.
18. Certified Photocopy of all works by concern Officer.
19. Description/Photocopy of work site location before start of work/Starting of work/Ending of work site.
20. Billing details Sheet copy in particular RFO wise.
21. Scheme details Sheet particular Range Forest Officer (RFO) wise.
22. NIT Copy/Date of NIT Tender floated or Conducted/Total number bidders/Total Apply of firms/Name of Selected Firm & Contractors/Press Letter Paper Cutting/Awarded firm details with Cheque book counterfoil/leaf/demand draft/banker cheque/deposited challan and PFMS Transaction details as according to the amount mentioned in work order in/sanction order with account Number of firm/ Contractor.

This appeal is listed and heard for the 2<sup>nd</sup> time today on 02.07.2025, the 1<sup>st</sup> time being on 2<sup>nd</sup> May, 2025 wherein one of the appellants, Shri Riya Taram was present and the PIO Shri Arup Kr. Deka, CF-cum-Field Director, Namdapha National Park & Tiger Reserve, Miao, Changlang Distt. attended the hearing through video conference.

In the haring on 02.05.2025 the PIO submitted that the requested documents/information were furnished to the appellant on 16<sup>th</sup> December, 2024 through post office but the appellant submitted that he did not receive the documents.

This Commission, upon hearing the parties, had then directed the PIO to furnish the documents again to the appellants within 10 days from the date of receipt of the Commission's order through messenger and the appellant was also directed to inform this Commission of the receipt of the documents within one week thereafter

In compliance with the order of this Commission, the PIO, vide letter dt.13.05.2025 had furnished the requested information through a Special Messenger, Shri Munna Sharma from the o/o the PIO with intimation to this Commission.

The appellant, Shri Riya Taram, vide his 26.05.2025 addressed to this Commission, however, expressed his dissatisfaction with the documents so furnished to him saying that the documents were not furnished as per his RTI application in Form-A and therefore, pleaded for hearing the appeal again. This appeal is, therefore, listed again today on 2<sup>nd</sup> July, 2025.



The PIO attended the hearing through VC again but the appellant is absent who informed vide his letter dt.02.07.25 posted in WhatsApp that he is undergoing medical treatment and requested for adjournment of the hearing.

The PIO, reiterating his statement in the letter dt.13.05.2025 regarding the particulars of requested information as "**general nature and not related to specific items of work**", pleaded for direction to the appellant to be specific in seeking information on the release of funds.

As prayed for by the PIO, the appellant is directed to mention and explain clearly the specific points on which information/replies have been missed out on or before 18.07.2025 failing which this appeal shall be closed without further notice.

List this appeal again on 01.08.2025.
