WHEREAS, the 2nd hearing was held on **29th January, 2024** related to the APIC No-962/2023 (Appeal). Both the parties found absent

WHEREAS, during last hearing dated on **18/12/2023**, the representative of the PIO handed over all the information to the appellant. Accordingly, the appellant received the information and after going through the information, appellant reported to the Commission that the information which furnished are without CTC & incomplete, so he returned back the information to the representative of the PIO.

WHEREAS, the Commission after going through all the information available and also heard from both the parties and directed the PIO to furnish all the information correct, clear and authentic with proper CTC, seal & signature of the PIO to the appellant on or before next date of hearing **29/1/2024**. But he failed to comply the direction of the Commission.

WHEREAS, therefore, the Commission viewed seriously on the reluctant attitude of the PIO by disobeying the direction/order of the Commission in the last hearing on dated 18/12/2023 and also he remained absent consecutively twice from the hearing dated on 18/12/2023 & 29/01/2024.

WHEREAS, so, the Commission also directed to issue warning summon notice to PIO for his appearance before the Commission in next date of the hearing and also directed to furnish all the information correct, clear and authentic with proper CTC, seal & signature of the PIO as sought by the appellant in his form 'A' application to the appellant on or before next date of the hearing. Failing which, necessary action shall be initiated against the PIO as per the RTI Act, 2005.

WHEREAS, the Commission directed the appellant to present in person before the Commission in the next date of hearing. Failing which, his appeal No. APIC-962/2023 shall be decided as ex-parte and dispose off.

The Commission fixed next date of hearing on **1st May, 2024 at 2 PM.**
