Summon Notice.

The 1st hearing was held on **24th September 2025** related to the **APIC No-256/A/2025(Appeal)**. Both the parties appellant Shri Tamchi Gungte and the PIO-cum-EE (PWD), Bomdila Division found absent without any intimation to the Commission.

After going through the case record, it is seen that the First Appellate Authority has passed an order dated 15/01/2025 on the day of hearing before the First Appellate Authority, the appellant was absent and the respondent PIO was present in person.

The PIO had brought all the information as sought by the appellant on the day of hearing but due to absence of the appellant the documents could not be handed over to him.

As per the order made by the First Appellate Authority, the appellant was given 15 (fifteen) days times to collect the information from the office of the PIO-cum-EE(PWD), Bomdila Division and was asked to intimate before the FAA whether he is satisfied by the information provided. The First Appellate Authority has stated that if no intimation is received from the appellant after 15 (fifteen) days, it shall presume that the appellant is satisfied by the information furnished by the PIO.

Today both the parties found absent, the appellant is directed to collect the information from the office of the PIO-cum-EE(PWD), Bomdila Division and intimate before the Commission on or before next date of hearing. If no intimation is received from the appellant, the Commission will presume that the information has been furnished and he is satisfied.

Last chance is given to the appellant to appear before the Commission. If found absent in the next date of hearing, the Commission will decide the case in his absence.

The Commission fixed next date of hearing on 08/12/2025 at 1030 hours,


