An Appeal Case U/S 19(3) of RTI Act, 2005

RESPONDENT : a) The PIO, o/o the EE (PWD) Sangram Division, Sangram.
b) The PIO, o/o the E.E (PWD) Koloriang Division, Koloriang.

ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Pisa Takey for non-furnishing of below mentioned information by the PIO, o/o the EE (PWD) Sangram Division, Kurung Kumey District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 03.01.2025.

A) Particulars of information: C/o approach road construction from BRO Helipad Lee to CO-cum-BDO Residence via Hospital, General ground CO-cum-BDO office Sarli Town.

B) Details of information:

1. DPR of the said project in details;
2. Work order of the said project;
3. MIS report geo tagged report and geo tagged certificate;
4. Name of the firm in details;
5. NIT date of publication copy (local news paper cutting c/o said project);
6. Total fund allocation for the project said;
7. Technical sanction copy of the project and
8. Board member of the said project at the time of NIT in designation with sign details.

C) Period for which information asked for: 2023-2025.

This appeal has been listed for the 3rd time today on 29.04.26, the earlier 2(two) times being on 25.02.2026 and 25.03.25.

On 25.02.26, wherein the appellant, Shri Pisa Takey and Shri Bini Tare, the PA-cum-RTI i/c, representing the PIO, o/o the EE (PWD) Sangram Division were present in person, this Commission, upon hearing the representative of the PIO who submitted that with the bifurcation of the Koloriang PWD Division from the Sangram PWD Division, the documents pertaining to the schemes coming under the jurisdiction of Koloriang Division, including the RTI matters, had been transferred to the Koloriang, decided to hear both the PIOs of Sangram Division and the Koloriang Division together to resolve the question as to whose office shall furnish the requested information/documents to the appellant.

This Commission, therefore, vide order dt. 25.02.26, directed the said PIOs to be present in person in the next hearing on 25.03.2026 with records / evidence of

handing over and taking over of the charges of records/documents pertaining to schemes falling under the jurisdiction Koloriang Division.

On 25.03.26, however, both the PIOs did not appear, probably, due to pre-occupation in financial year ending works. The hearing was, therefore, adjourned to 29th April, 2026.

Today on 29.04.26 the appellant, Shri Pisa Take is present in person while the PIO, Sangram Division is again represented by Shri Bini Tare, the PA-cum-RTI i/c. But the PIO, Koloriang Division is yet again absent despite repeated Summon notices through Whatsapp due to whose absence the question as to whose Division shall furnish the requested information to the appellant, still remains unresolved.

This appeal is, therefore, listed again on 29.05.2026 wherein both the aforesaid PIOs must be present and resolve the teething question. In view of repeated absence of the aforesaid two PIOs, particularly, the PIO, Koloriang Division, in the hearings, this Commission is compelled to issue warning to both the PIOs that if they fail to appear in the next hearing, the penal provisions of section 20 of the RTI Act, 2005 shall be invoked against both of them.

NOW THEREFORE, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on the 29th May, 2026 (Friday) at 2 pm** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
