## ARUNACHAL PRADESH INFORMATION COMMISSION ITANAGAR.

An Appeal Case U/S 19(3) of RTI Act, 2005

Case No. APIC- 703/2025.

(Summon to appear in person)

### ORDER./SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho for non-furnishing of below mentioned information by the PIO, o/o the EE (PWD), Sangram Division, Kurung Kumey District Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 04.06.2025:

**A. Particulars of the Information:** Under Budget Estimate (BE)2024-2025.

1. c/o Road from Patuk PWD road to ADC Office Patuk, Parsi Parlo Circle under Koloriang Kurung Kumey District under SASCI-2024-25;
2. c/o Helipad at Malapu near Circuit House Koloriang, Kurung Kumey District under BE 2024-25;
3. c/o office building for CO Paniasang and Polosang, Kurung Kumey District under BE- 2024-25;
4. c/o G+2 Type II and Type III Quarter for District Administration in Koloriang, Kurung Kumey District under BE 2024-25;
5. c/o G+2 RCC School Building for Academic Block at Govt. Hr. Secondary School in Koloriang, Kurung Kumey District under BE 2024-25 and
6. Infrastructure Development within VKV School Koloriang, Kurung Kumey District under BE 2024-25.

- i. Work order by particular name/firm;
- ii. DPR;
- iii. Technical Sanction order copy (TS);
- iv. Acceptance Letter;
- v. Commence Letter;
- vi. Technical Bid;
- vii. Tender Agreement copy and

**C) Period for which information asked for : 2024-2025**

**Brief facts emerging from the appeal :**

Records emerging from the appeal disclose that the appellant, Shri Bamang Pacho had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer , (PWD), Central Zone-A, Itanagar, Govt. of A.P, the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt. 18.07.2025 .

Records further reveal that the First Appellate Authority-cum-Chief Engineer, Central Zone-A, PWD, AP, Itanagar conducted a hearing on 20<sup>th</sup> August, 2025 wherein the appellant Shri Bamang Pacho was present but the Respondent PIO, EE. Sangram Division was absent and the FAA taking a serious view of the absence of PIO or any representative passed the following order:

*"In accordance with the hearing notice dated 30/07/2025, the appellant is present but the respondent PIO is absent for the case hearing on RTI 15t appeal received on 22/07/2025 regarding non furnishing of documents by P10 cum Executive Engineer, Sangram Division, PWD against two applications demand are same in both the applications. The P10 is contacted over phone and he is ready to provide the documents. The absence of PIO or any representative of him for the case hearing is taken seriously by the undersigned.*

*Therefore, the respondent PIO is directed to furnish the sought information within 20 days from the date of issue of this order with intimation to this office.*

*Accordingly these two cases stand disposed of with liberty to the appellant to prefer second appeal to the State Information Commission as per section 19(3) of the RTI act.*

However, the appellant failed yet again to obtain the information and therefore, he preferred 2<sup>nd</sup> appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of appeal dt. 12.09.2025.

**Hearing and decision:**

Accordingly, this appeal is listed today on 10<sup>th</sup> December, 2025 wherein the PIO, Er. Shri Modak Riba accompanied by his P.A and i/c RTI Cell were present in person but the appellant, Shri Bamang Pacho was absent without any intimation.

Heard the PIO who submitted that pursuant to posting of an EE at Koloriang Division and handing and taking over of the charges of subjects pertaining to the Koloring Division, the PIO, o/o EE, Sangram Division, vide letter dt. 03.12.2025, has already asked the PIO, EE, Koloriang Division, PWD, to take necessary action on RTI application in question pertaining to Koloriang jurisdiction, the relevant portion of which is reproduce hereunder:

*"Sir,*

*In inviting reference to the above cited subject enclosed please find herewith APIC hearing summon served vide Memo no. APIC-703/2025/722 Dtd. 19/11/2025 in connection of APIC case no. APIC-703/2025 filled by Shri Bamang Pacho as the case is pertaining to your jurisdiction division has been addressed to the undersigned.*

The pending RTI cases has clearly reflected in the solemnized handing and taking over of charges between the PIO, Sangram division, PWD and PIO Koloriang division, PWD which may be take reference from.

This is for information and necessary action please.
