**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Chou Chali Simit, Village-Manfaiseng, PO – Nanam Shyam, Namsai District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-BDO, Lekang CD Block, Mahadevpur, Namsai District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 04/03/2025 regarding Supply & Procurement of Materials under MGNREGA.
- 2). The 1<sup>st</sup> hearing was held on 15<sup>th</sup> October' 2025. Shri Tojum Ete, PIO-cum-BDO, Lekang CD Block, Mahadevpur, Namsai District, Arunachal Pradesh was present. The Appellant had appeared before the Commission through video conferencing.
- 3). The PIO submitted that since the information sought were voluminous, the Appellant was asked to submit list of specific information, but the Appellant failed to turn up.
- 4). The Commission after hearing both the parties, asked the Appellant to make specific list of information as required, submit the list to the PIO and collect the required information from the PIO within fifteen days from the date of issue of the order dated 15<sup>th</sup> October'2025. The PIO was also directed to submit action taken report to the Commission, but the PIO till date has not submitted any action taken report.
- 5). The Appellant was asked to submit a copy of the list to the Commission and intimate in writing, his satisfaction or dissatisfaction after receipt of the information, but the Appellant vide letter dated 30/10/2025 submitted that the information sought by him are not voluminous, that the information sought are specific and requested the PIO to furnish information as sought by him in his RTI Application dated 04/03/2025.
- 6). The Commission giving reasonable opportunity to both the parties decides to fix a date of hearing.
- 7). **The next date of hearing is fixed on 10<sup>th</sup> February'2026 (Tuesday) at 1100hrs.**

8). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
