ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Lebe Dolo, Polo Colony, Naharlagun, Arunachal Pradesh for non-furnishing of information by the SPIO-cum-Deputy conservator of Forest, O/o the Principal Chief Conservator of Forest Itanagar, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 30/01/2023 regarding the matter of Village Reserve Forest (VFR)/Anchal Reserve Forest (ARF) of Arunachal Pradesh.

The 4th hearing is held today on 2nd April, 2024 as scheduled. Shri B. Pradhan, the SPIO-cum-Deputy conservator of Forest, O/o the Principal Chief Conservator of Forest Itanagar, Arunachal Pradesh and the Appellant Shri Lebe Dolo is present. The Appellant has submitted that he has gone through information so furnished and found that there are confusing in understanding and locating information as sought in his application in Form-a on 30/01/2023 and appealed the commission to give fair opportunity to go through the information as furnished and to visit the office of the PIO to get clarification on the confusing parts found. The PIO agreed to clarify the confusion if the appellant visit his office.

The Commission directs the Appellant to visit the office of the PIO on 8th April, 2024 (Monday) 1030hrs and get all clarification. After the clarification from the PIO the appellant is directed to intimate the commission for its further action. The PIO is also directed to be present on above said date and time in his office for the clarification. Failing which the commission shall be compelled to initiate penal action under section 20(1) of the RTI Act, 2005 and if the appellant fails to comply above direction the case shall be disposed of. The court is adjourned for the next date of hearing.

Both the parties are directed to be appear in person before the court on the next date of hearing. In case the SPIO is found absent the penal provision under section 20(1) of the RTI Act shall be imposed on him and in case the Appellant is found absent the case shall be disposed of presuming that the Appellant is satisfied with information furnished by the SPIO without any further notice.

The next date of hearing is fixed on 30th April, 2024 (Tuesday) at 1030 hrs.

Therefore, Shri B. Pradhan, the SPIO-cum-Deputy conservator of Forest, O/o the Principal Chief Conservator of Forest Itanagar, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.

Order be issued to both the parties.
