ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Chow Lajamang Mannow, Village Nanam Khamti, P.O. Manmow, Namsai District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(PWD), Govt. of A.P., Roing Division, Lower Dibang Valley District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 07/03/2025 regarding Improvement of Bomjir – Paglam road (Bizari to Anpum, L-13.400 km).
- 2). The 2nd hearing was held on 11th November' 2025. The PIO-cum-EE(PWD), Govt. of A.P., Roing Division, Lower Dibang Valley District, Arunachal Pradesh was represented by Shri Ajai Taji, APIO-cum-JE (PWD) Roing Division. The Appellant Chow Lajamang Mannow was present.
- 3). The Commission had directed the PIO to furnish information to the Appellant and cautioned that if information was not furnished on the visit by the Appellant, the PIO would be made to pay compensation to the Appellant under section 19(8)(b) of the RTI Act 2005.
- 4). The Commission also asked the Appellant to collect the information from the office of the PIO within 15 (fifteen) days from the date of issue of the order dated 11th November'2025 and intimate the Commission in writing, his satisfaction or dissatisfaction after receipt of information.
- 5). The Appellant vide letter dated 25/11/2025 intimated that the PIO had not furnished complete information and appealed the Commission to fix next date of hearing.
- 6). The Commission in view of the order dated 11th November'2025 decided to fix one more date of hearing.
- 7). **The next date of hearing is fixed on 10th February'2026 (Tuesday) at 11:00 am.**

8).Therefore, the PIO-cum-EE(PWD), Govt. of A.P., Roing Division, Lower Dibang Valley District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

9). Take notice that in case of default in appearance on the day of hearing mentioned above, the appeal will be heard and determined ex-parte. If the PIO is found absent, Section 20 (1) of the RTI Act, 2005 shall be invoked against him/her. If the Appellant is found absent the case shall be disposed of.
