HEARING NOTICE

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Sengman Ronrang, Sinwang Village, PO/PS Manmao, District Changlang, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-DLRSO, Govt. of A.P. Changlang HQ, District Changlang, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 09/07/2025 regarding Border Road from 'O' point via Tengman village to Hetman village under Manmao circle.
- 2). The 1st re-scheduled hearing was held on 3rd February' 2026. Shri Taba Torum, PIO-cum-DLRSO, Govt. of A.P. Changlang HQ, District Changlang, Arunachal Pradesh had appeared before the Court through Video Conferencing. The Appellant Shri Sengman Ronrang was present in person.
- 3). The Commission in view of Section 24 of the RTI Act 2005 read in conjunction with government circular and representation of the GBs, had directed the PIO to furnish only the list of beneficiaries to the Appellant, the information that does not fall under exemption category.
- 4). The Appellant vide letter dated 13th February' 2026 informed the Commission that no action has been taken by the PIO as directed by the Commission in the order no. APIC-732/A/2025 Dated, Itanagar the 3rd February' 2026
- 5). The Commission giving reasonable opportunity to the PIO decides to fix a date of hearing.
- 6). **The next date of hearing is fixed on 21st April'2026 at 1100hrs.**
- 7). **Therefore,** the PIO-cum-DLRSO, Govt. of A.P. Changlang HQ, District Changlang, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

8). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked against the PIO and in case the Appellant remains absent the case would be disposed of.
