## ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, & Shri Takam Sakap, C/o Hotel Chandini, E-Sector, Naharlagun, Papum Pare District Arunachal Pradesh for non-furnishing of information by the PIO-cum-EE (PHE & WS) Govt. of A.P., Daporijo Division, Upper Subansiri District, Arunachal Pradesh as sought for by the Appellant under section 6(1) of RTI Act, 2005 on 03/08/2022 regarding allocation of Fund under Jal Jeevan Mission (JJM) for support activities and (MQM&S) from Mission Director Govt. of A.P. etc.

The 7<sup>th</sup> hearing is held today on 30<sup>th</sup> January, 2024 (Tuesday) as scheduled. The SPIO-cum-EE (PHE & WS) Govt. of A.P., Daporijo Division, Upper Subansiri District, Arunachal Pradesh is represented by Shri Hilang Raj, APIO-cum-JE, PHED, the APIO. The Appellant Shri Riya Taram is present. The representative of the PIO handed over a bunch of document claiming to be the information sought by the appellant, which is received by the Appellant. The Appellant made certain observation that the information so furnished is incomplete. Considering the observation made by the Appellant the commission directs the appellant to go through documents so furnished by the PIO and make a proper list of information which are not furnished and give the list of the incomplete information to the PIO within seven days from the issue of this order. Failing which the commission shall dispose of the case without any further notice. On receipt of the list, the PIO is directed to furnish remaining information to the appellant within twenty days from the issue of this order failing which penal action shall be taken against him.

Both the parties are directed to appear before the commission's court on the next date of hearing. In case the SPIO remains absent the penal provision under section 20(1) of the RTI Act 2005 shall be imposed and in case appellant remains absent the case shall be disposed of without any further notice, presuming that he is satisfied with the information furnished by the PIO. The court is adjourned for the next date of hearing.

The next date of hearing is fixed on 16th April, 2024 (Tuesday) at 1030 hrs.

Therefore, the SPIO-cum-EE (PHE & WS) Govt. of A.P., Daporijo Division, Upper Subansiri District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
