SUMMON

WHEREAS, in connection with the <u>APIC-No. 122/2025</u>, your personal appearance is required before the Commission on 10th July, 2025 at 10:30 AM. The 1st hearing held on 22nd Apri'2025, related the APIC No.122/2025. The Appellant represented by Adv. Dope Ori, present during the hearing but the PIO–cum Asst. Director Textile & Handicraft Sericulture, Yupia, found absent without intimating the reason for his inability to attend the hearing which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides public duties, also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty upon the PIO.

Heard the representative of the Appellant.

The representative of the Appellant reported to the Commission that the Appellant has not received any information from the PIO till date as sought by him in his form 'A' application.

After hearing the representative of the Appellant, the Commission has seriously viewed the absence of the PIO.

The Commission hereby orders;

- (i) To <u>summon</u> the PIO to appear in person or through online mode before the Commission in the next date of hearing.
- (ii) The PIO to provide all the information(s) to the Appellant on or before the next date of hearing as sought in his form 'A' application. Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act 2005.
- (iii) The next date of hearing has been intimated to the Appellant. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 10thJuly 2025 at 10:30 AM (Morning)
