WARNING SUMMON

WHEREAS, in connection with the **APIC-No. 140/2025**, your personal appearance is required before the Commission on **19 March, 2026 at 10:30 AM**. The 2nd hearing held on **13th November' 2025**. The Appellant Miss Bengia Mama is present. The PIO-cum-DDSE, Daporijo, Upper Subansiri District, Govt. of Arunachal Pradesh, found absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

Heard the Appellant;

The Appellant stated before the Commission that she received some of the information(s) from the office of the PIO but the information(s) received are in-complete.

As the PIO is absent, the hearing could not proceed, so the hearing be fixed on another date and therefore, the Commission hereby orders;

- i) To **send warning summons** to the **PIO-cum-DDSE Daporijo**, Upper Subansiri District to be present in the next date of hearing without fail, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- ii) The Appellant to be present in person or through online mode in the next date of hearing, **failing which this instant appeal will be heard and determined ex-parte**.
- iii) Notice need not be issued to the Appellant as she is present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 19th March' 2026 at 10:30 AM (Morning).
