## ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tago Kochung, Village- Yorko, Po/Ps-Mechukha, Shi-Yomi District, Aruachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PWD), Govt. of A.P., O/o Public Works Department, Mechukha, Shi-Yomi District, Aruachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/05/2023 regarding C/o Road from BRF Road Karo to Pidi Circle.

The 1<sup>st</sup> hearing is held today on 30<sup>th</sup> January, 2024 as scheduled. The PIO-cum-EE (PWD), Govt. of A.P., O/o Public Works Department, Mechukha, Shi-Yomi District, Aruachal Pradesh is represented by Shri Ree Taso, APIO-cum-AE. The Appellant Shri Tago Kochung is present. The APIO brought certain information and furnished to the Appellant. The appellant after receiving document has rejected stating that the information furnished are not as per Form-A application submitted by him. The Commission directs the Appellant to seek information of one work, one financial year. The appellant has chosen to seek information for the financial year 2021-2022. The PIO is directed to furnish information within twenty days from the date of issue of this order directly to the Appellant with intimation to the Commission. The appellant is directed to visit the office of the PIO and collect information within twenty five days from the date of issue of this order and intimate to the commission.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

The next date of hearing is fixed on 23rd April, 2024 (Tuesday) at 1030 hrs.

Therefore, the PIO-cum-EE (PWD), Govt. of A.P., O/o Public Works Department, Mechukha, Shi-Yomi District, Aruachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
