**NOTICE**

The 1<sup>st</sup> hearing held on **2<sup>nd</sup> day of July' 2026'** related to the **APIC No-330/A/2026**. The Appellant Shri Bengia Papo is absent with a letter of absence and an authority letter authorizing Mr. Gechik Tadik to represent him before the court today.

The PIO-cum-Executive Engineer (EE), UD & Housing, Koloriang Division, Kurung Kumey District, Govt. of Arunachal Pradesh is present through online mode during the hearing before the Commission.

**Heard the representative of the Appellant;**

The representative of the Appellant stated that the Appellant has not received any information from the PIO, till today.

**Heard the PIO;**

The PIO stated that whatever information as applied have been furnished to the Appellant and the Appellant has personally received the information(s) on 18.04.2026 from the office of the PIO, the receipt of which is available with the PIO.

The Appellant had preferred the First Appeal before the First Appellate Authority (FAA) who is the Chief Engineer (CE) UD & Housing, Govt. of Arunachal Pradesh, wherein, also after the hearing the PIO has provided the information to the Appellant.

After hearing both the parties the Commission hereby order as follows;

- i) The Appellant to be present in the next date of hearing without fail to confirm the receipt of the information from the PIO, the Appellant is also ordered to be present in the next date of hearing without fail, failing which the Commission will presume that the information(s) have been provided to the Appellant completely, and therefore, this appeal will be heard and determined ex-parte by disposal of this appeal.
- ii) The PIO to be present in the next date of hearing without fail, failing which necessary action as provided under RTI, Act, 2005 will be initiated against the PIO.

- iii) Notice need not be sent to both the parties as they are present during the hearing before the Commission.

**The Commission hereby orders;**

**The next date of hearing be fixed on 10<sup>th</sup> day of September' 2026 at 10:30 AM (Morning).**


