This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tajo Ngomle for non-furnishing of below mentioned information by the PIO, o/o the Commissioner Department of Personal, Govt. of A.P, Block-IV, 4th floor, Civil Secretariat Itanagar as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 17.10.2025.

**A. Particular of information:** Arunachal Pradesh Public Service Commission Combined Competitive Examination 2024 (Advertisement No. PSC-R(A)/12/2024, date 10.10.2024) and APPSCCE-2025 (Final result Notification NO. PSC-R(A)02/2024 (Vol-iii), dated 08.08.2025

Take notice that, in default of your appearance, on the day above-mentioned, the matter will be heard and determined in your absence.


