SUMMON / ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri TamchiGungte for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (PHED),, Bordumsa Division, Dist. : Changlang, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 04.09.2024.

A) Particular of information: C/o "Augmentation of water supply at Miao Township (3.5 MLD) in Changlang District" under the North East Infrastructure development Scheme in Arunachal Pradesh during the financial year 2019-20

B)Details of information required :

- 1. Certified sanction order copy of the total list of project mentioned above.
- 2. Total lists of work components of the projects.
- 3. The certified copy of Notice Inviting Tender (NIT) with respect to the subject mentioned above.
- 4. The certified copy of Newspaper in which the NIT was published (at least 3 newspaper names (one national & 2 local) along with the date of publication of newspaper ass per Govt. approved order.
- 5. The Tender Evaluation copy 9Technical Bid) along with the list of Firms participated in the tender processed of the work.
- 6. The name of firm who won the tender work with respect to the subject mentioned above:
- 7. The certified copy on which date the project has been started.
- 8. The Geo Coordinate information for work mentioned above.
- The certified full agreement copy made in between the executing agency and the firm owner.
- 10. The certified copy of contractor enlistment of the winning firm.
- 11. The certified copy of contractor enlistment update reports, of tender winning firm.
- 12. The certified affidavit copy sworn before a competent magistrate to the effect that he/she does not have 2 (two) or more incomplete ongoing commitment (Project/contract to execute) at the time of bidding by the tender participant and winning firm. (as per rule SPWD/W-66/2012 Dtd. 01-08-2018).

13. The certified copy of declaration letter from the contractor (if the tender participant is from different state) to the effect that he/she has not been debarred from tendering by authority in which contractor is registered (As per CPWD Works Manual 2014, Section 15.2.3(2).

The appellant, vide his application dt.04.09.2024, had requested for the aforementioned information from the PIO but failed to obtain the information which prompted him to file his 1st appeal before the Chief Engineer (PHED), Eastern Zone, Namsai, the First Appellate Authority (FAA) under section 19(1) of the RTI Act, 2005 vide his Memo of Appeal dt. 12.10.2024. However, having failed to receive any response from the FAA within the statutory period, the appellant approached this Commission by filing his 2nd Appeal under section 19(3) of the RTI Act, 2005 vide Memo of Appeal dt.25.11.2024 which has been registered in this Commission as APIC-413/2024 and listed for hearing on 26.03.2025.

The Appellant, Shri Tamchi Gungte was present in person and the PIO, Er. Shri Kipa Niama, EE(PHED), Bordumsa Division attended the hearing through VC.

Heard the parties.

The PIO submitted that he had already furnished the sought for information to the appellant but he is surprised to find that the appellant had filed his appeals before the FAA and the Commission. The Appellant responded by saying that he received the documents through post after filing the First and Second appeals on expiry of the statutory periods of the furnishing the information and the response from the FAA. The appellant produced before the Commission the documents furnished by the PIO which he claimed as incomplete considering the fact that he had deposited a sum of Rs. 11,500.00. He also pleaded for 2(two) days time to go through the documents and intimate his satisfaction or otherwise therewith.

This Commission, upon hearing the parties, directed the appellant to go through the documents furnished by the PIO and intimate his satisfaction or otherwise therewith within 2(two) days from 26/03/2025.

In compliance with the Commission's order dated 26th March, 2025 the appellant has submitted a letter dated 26.03.2025 wherein he has expressed his dissatisfaction with the documents supplied by the PIO on the ground that the same are incomplete as per his application in form A namely Sl. Nos. 4, 12 and 13

In the premises as above, this Commission deems it necessary to hear the appeal again. The PIO o/o the Executive Engineer (PHED), Bordumsa Division, Dist : Changlang (A.P) is, therefore, summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person on 11th April, 2025 (FRI DAY) at 2 pm to answer the claims, and your are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.
