### **SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho for non-furnishing of below mentioned information by the PIO, o/o the EE (PWD), Sangram Division, Kurung Kumey District Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.02.2025.

**A. Particulars of the Information:** Under Budget Estimate (BE) 2023-2024.

1. Augmentation and Retrofitting of old existing "DC Office at Koloriang Kurung Kumey District (Phase-I).
2. C/o Residential Building 2nos of type-II & 2nos. Type-III for staff of District Administration at Sarli CO Har. Kurung Kumey District.
3. C/o Pla Ground with RCC Gallery VKV School Koloriang Kurung Kumey Dist.
4. C/o T 1e-II Teacher Qtr. 2nos. with CC Wall upto window level and Dyna sheet roofing with steal trust for Govt. Middle School Taba under Damin circle Kurung Kumey District (A.P)
5. C/o School Building Govt. Middle School Koloriang Bhaluklong

**B. Details of Information required:**

- i. Work order by particular name/firm.
- ii. MB Note
- iii. DPR
- iv. Cheque counter foil particular by name;
- v. LOC
- vi. 3 times geo tagged photo
- vii. Payment details
- viii. Details of credit amount
- ix. Details of account number in which amount credited.
- x. Bank & Branch Name which amount credited from concerned department
- xi. Completion Certificate.

**Period for which information asked for:** 2023-2024

This appeal was heard on 08.10.2025 wherein the appellant, Shri Shri Bamang Pacho was present in person but the PIO was absent who, however, informed vide his letter dt.06.10.2025 that he will not be able to attend the hearing scheduled due to his pre-occupation in handing and taking over charges of newly bifurcated Koloriang Division, PWD, Koloriang and ***requested for adjournment of the hearing.***

The PIO had enclosed copy of letter dt.24.09.2025 from the SE, Yachuli Circle, directing the offices of the EE, Sangram Division and the EE, Koloriang Division to effect the handing over and taking over of charges with immediate effect.

The Commission, having considered the request of the PIO and also the points on which the appellant had requested information which were found not exempted under the exemption provision of the RTI Act, directed the PIO to furnish the documents within 1(one) month from the date of receipt of the order and the appellant was also directed to intimate this Commission about his satisfaction or otherwise therewith within 1 (one) week, thereafter.

In the meanwhile, the PIO (EE, Sangram Division), vide his letter dt.16.10.2025, has informed that consequent upon bifurcation of Koloriang Division from the Sangram Division and pursuant to SE's order dt.24.09.2025, the handing over and taking over of the charge of the Koloriang Division has been done on 14.10.2025 and that consequently for the pending RTI cases till 14.10.2025 in respect of the Koloriang Division, the EE (Koloriang Division) be summoned.

The appellant, Shri Bamang Pacho, vide his letter dt.29.10.2025, however, has complained that the PIO did not furnish him the requested information despite this Commission's order dt.09.10.2025.

In the premises as above, this Commission deems it appropriate to summon the PIOs of both the Sangram Division and Koloriang Division in the next date to hear them and decide as to whose Division shall provide the requested information.

**NOW THEREFORE**, the EE-cum-PIO, Sangram PWD Division and the EE-cum-PIO, Koloriang PWD Division are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on the 21<sup>st</sup> January, 2026 (Wednesday) at 10:30 am** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
