The 1<sup>st</sup> hearing held on **2<sup>nd</sup> day of July' 2026'** related to the **APIC No-335/A/2026.**  
The Appellant Shri Ratan Chetia is present through online mode during the hearing before the Commission.

The PIO-cum-Block Development Officer (BDO), Namsai, Namsai District, Govt. of Arunachal Pradesh is present through online mode during the hearing before the Commission.

**Heard the Appellant;**

The Appellant stated that the PIO has allowed him to inspect the documents after the order from the First Appellate Authority (FAA) and after the inspection I have satisfied myself with the information available at the office of the PIO. Among the information that I have applied for and numbered serially, the information for the Serial No. (m) only may be provided to him by the PIO and those are: certified copies of sanction order, fund release order, expenditure statements of MGNREGA in Namsai block for the last three financial year i.e 2022, 2023 & 2024, rest information have been received from the office of the PIO.

**Heard the PIO;**

The PIO stated that almost all the information pertaining to the particular scheme are available suo moto in the Website of the Department, the Appellant can inspect the information because all the information are available in the Website of the Department in public domain.

Regarding the information as applied under S/No. (m) of the Form-A of the Appellant, the PIO assured the court of the Commission to provide the said information on or before the next date of hearing to the Appellant.

After hearing both the parties the Commission hereby order as follows;

- i) The PIO to provide the information applied under S/No. (m) of the Form-A of the Appellant for the financial year 2022, 2023 & 2024 on or before the next date of hearing.

- ii) The Appellant to contact the office of the PIO and collect the information from the office of the PIO after intimation from the PIO that the information are ready to be furnished to him.
- iii) The Appellant to be present in the next date of hearing without fail, failing which the Commission will presume that the Appellant has been furnished the information completely by the PIO, and therefore, the absence of the Appellant in the next date of hearing will lead to disposal of this appeal ex-parte.
- iv) The PIO to be present in the next date of hearing without fail to let the Commission know whether the information(s) have been provided to the Appellant or not.
- v) The failure of the PIO to attend the next date of hearing will result in invoking necessary action against the PIO as provided under RTI, Act, 2005.
- vi) Notice need not be sent to both the parties as they are present during the hearing before the Commission.

**The Commission hereby orders;**

**The next date of hearing be fixed on 10<sup>th</sup> day of September' 2026 at 10:30 AM (Morning).**


