**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Palen Laa & Smti Yukar Yaga, c/o Jullang near Sonam Nursery, Po/Ps-Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-EE(RWD), Govt. of A.P., Raga Division, Kamle District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/06/2023 regarding Expenditure and implementation of SADA/SID/RE/ADA/RIDF of entire Kamle District.

**The 2<sup>nd</sup> hearing is held today on 6<sup>th</sup> February, 2024 as scheduled.** The SPIO-cum-EE(RWD), Govt. of A.P., Raga Division, Kamle District, Arunachal Pradesh is represented by Shri Buru Sambio, UDC. The Appellant Shri Palen Laa is present. The representative of the PIO has submitted that the information sought for has already been furnished to the Appellant. On the other hand Appellant has made his submission that information so furnished are incomplete and in compliance with the Commission's direction, a list of the incomplete information was submitted to the PIO on 29<sup>th</sup> January, 2024 through whatsapp and hard copy. After going through the documents available and hearing from both the parties the Commission directs the PIO to furnish complete authenticated correct information to the Appellant within fifteen days from the date of issue of this order. Further, if some of the information sought for are not available a clear justifiable reasons in writing under seal signature of the PIO be furnished to the Appellant. The process must be completed within fifteen days from the date of issue of this order.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

**The next date of hearing is fixed on 9<sup>th</sup> April, 2024 (Tuesday) at 1030 hrs.**

**Therefore,** the SPIO-cum-EE(RWD), Govt. of A.P., Raga Division, Kamle District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
