SUMMON

WHEREAS, in connection with the APIC-No. 821/2025, your personal appearances required before the Commission on **21st May 2026 at 10:30 AM**. The 1st hearing held on **5th March' 2026**. The Appellant Shri Ashok Sangbia is present through online mode during the hearing before the Commission.

The PIO-cum-EE, WRD, Sagalee Division, Papumpare District, Govt. of Arunachal Pradesh, found absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

Heard the Appellant;

- i) The PIO to provide all the information(s) to the Appellant on or before the next date of hearing, and to be present in the next date of hearing without fail, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- ii) The Appellant to be present in the next date of hearing in person or through online mode without fail, failing which this appeal will be heard and determined ex-parte.

- iii) Notice for the next date of hearing to be issued to the PIO to attend the hearing in person or through online mode without fail.
- iv) Notice need not be issued to the Appellant as he is present during the hearing before the Commission.

The Commission hereby orders;
