ORDER

The 5th hearing held on **3rd April, 2025** related to the **APIC No-219/2024**. Both the Appellant and the PIO are present through online mode, during the hearing before the Commission.

Heard the Appellant;

The Appellant stated before the Commission that he received the copies of the information(s) yesterday i.e on 2nd day of April' 2025 only, and therefore, he could not go through the whole information(s) and requested the Commission to give some time to go through the information(s) provided to him by the PIO. He further stated that information(s) pertaining to Serial Nos. (a) and (f) are received completely. But, information(s) pertaining to Serial No.(b) are provided in-complete for the reason that the information(s) sought in (b) are adjoining information(s) about the information(s) pertaining to (a). To be specific, the information(s) provided in regard to (b) are only of two stone crushers, 6(six) Brick kiln out of 11(eleven), in regard to Tea factories only 4(four) are provided. But, due to receipt of the information(s) just yesterday only, the Appellant could not go through the whole information(s). The information(s) in regard to Serial Nos. (c) and (g) have not been furnished by the office of the PIO till date. And, information(s) pertaining to Serial Nos. b, c, d, & e are in-complete and still some of the information(s) left to be provided.

Heard the PIO;

The PIO stated that all information(s) are not available in her office, those information(s) provided to her from the concern authority have already been provided to the Appellant. The remaining information not yet provided to the Appellant shall be provided to him on receipt from the competent officials those that keep the same.

After hearing both parties: the Commission hereby orders;

- (i) The PIO to provide complete information(s) to the Appellant on or before the next date of hearing, failing which appropriate action shall be initiated against the PIO as per the provisions of RTI, Act, 2005.

- (ii) Notice need not be issued to both the parties as they are present during the hearing before the Commission.

The next date of hearing be fixed on 19th June, 2025' at 10:30 AM (Morning).
