ORDER

The 4th hearing held on **3rd April, 2025** related to the **APIC No-209/2024**. The Appellant and the PIO both are present in person during the hearing before the Commission.

Heard the Appellant;

The Appellant stated before the Commission that till now he has not received any information(s) from the office of the PIO.

Heard the PIO;

The PIO stated before the Commission that he has taken over the charges as the PIO in the month of December' 2023, in the mean time the General and State Election was on the head, therefore, he could not be able to furnish the information(s) to the Appellant in time. Being free from the election process he compiled all the information(s) of 308 pages and called the Appellant to collect the information(s) sought under his Form-A application. But the Appellant denied to collect and told him that he will be collecting it from the Information Commission's Court. Therefore, all the information(s) have been brought today to be provided to the Appellant.

The Commission observes;

The present PIO who has been cooperative with the Appellant, who has compiled all the information(s) and even called the Appellant to his office to collect the information(s) seems to have no intention to harass the information(s) seeker/Appellant.

The PIO is allowed to hand over all the information(s) containing 308 pages to the Appellant before the Commission, and the Appellant received the information(s) during the hearing.

After hearing above facts and circumstance: the Commission hereby orders;

- (i) The Appellant to intimate the Commission about the information(s) received completely or not, on or before the next date of hearing, failing which this instant appeal shall be heard and determined Ex-parte.

- (ii) The presence of the PIO during the hearing before the Commission, engender the Bailable Warrant of Arrest which was issue against the PIO to be cancelled immediately and the Officer-In-Charge, Police Station Likabali, L/Siang District, is to be intimated of the cancellation of the same.
- (iii) Notice need not be issued to both the parties as they are present during the hearing before the Commission.

The next date of hearing be fixed on 19th June, 2025' at 10:30 AM (Morning).
