ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Licha Tabia & Shri Nabam Pekhi, Vill Dem. PO Deed, Ps Yachuli, Keyi Panor District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-BDO, CD Block Pistana, Keyi Panor District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 08/05/2025 regarding total sanctioned order copy for all the beneficiaries of Dem Panchayat under MGNREGA.
- 2). The 2nd hearing was held on 18th November' 2025. Shri John Diru, PIO-cum-BDO, CD Block Pistana, Keyi Panor District, Arunachal Pradesh was absent. The Appellant Shri Nabam Pekhi was present.
- 3). The Appellant submitted that the PIO had not furnished complete and detailed information. Along with his submission the Appellant submitted a letter dated 24/09/2025 raising question on the information as provided by the PIO.
- 4). On telephonic conversation the PIO informed that due to engagement in Election duty he missed the hearing date. However, the PIO appealed for consideration and also informed the Commission that if the Appellant was not satisfied with the information furnished he was ready to furnish further information.
- 5). The Commission cautioned the PIO that such an absence from the court hearing may invite penal action under the RTI Act. The PIO was directed to furnish requisite information to the Appellant within 15 (fifteen) days from the date of issue of the order.
- 6). The Appellant vide letter dated 02/12/2025 informed the Commission that the PIO had not furnished any information.
- 7). The Commission on appeal of the Appellant decides to fix a date of hearing.
- 8). **The next date of hearing is fixed on 10th February'2026 (Tuesday) at 1100hrs.**

9). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
