This appeal was listed for 2(two) times earlier on 03.07.2026 and 24.07.26 but the PIO was absent on both the dates without any intimation while one of the appellants, namely, Shri Tanya Ronya was present in person.

Taking a serious view of non-appearance of the PIO in the hearings, warnings were issued to the PIO that his repeated non-appearance shall constrain this Commission to invoke the penal provisions of the RTI Act, 2005.

The PIO, despite repeated warnings, did not appear nor deputed any representative for the 3rd time today on 31.07.2026. This appeal is, therefore, listed again on 26.08.2026 and in the meantime the PIO is directed to furnish the requested information/documents and / or the affidavit indicating the reasons/ explanation for the denial of the information to the appellants and report compliance thereof on the aforesaid date failing which penal action under section 20 of the RTI Act shall be initiated against him. ***And this order shall be treated as show cause notice.***

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
