ORDER/SUMMON

Shri Chungma Sangbia, Shri Rungme and Er. Gollo Bagang filed 2(two) appeals under Section 19(3) of RTI Act, 2005 for non-furnishing of below mentioned information by the PIO, o/o the S.E (Coordinator), (RWD), Itanagar, Govt. of Arunachal Pradesh as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 27.06.2025.

(1) Case No. APIC- 722/2025:

A)Particulars of information: Bio-data of 45-person, appointment letter and Advertisement, Promotion/Regularization/Record.

B) Details of Information:

- 1.Furnish the advertisement published in which local newspaper.
- 2.Furnish the date of interview of 45 persons.
- 3.Furnish the date of appointment letter of 45 persons.
- 4.Furnish the date of joining letter of 45 persons.
- 5.Furnish the educational qualification of 45 persons.
- 6.Furnish the service record of 45 persons.
- 7.Furnish the record copy of promotion or regularization of 45 person.
- 8.Furnish the recommendation letter from MLA/Minister or any higher official against the 45 persons.

A) Particulars of information: -Regarding date of joining and appointment letter of (1) Mr. Taro Tallo, (2) Mrs Taro Yami, (3) Mr.Taro Namu, (4) Miss Taro Chunzang, (5) Tajin Tayum and (6) Mr.Koj Tupe.

B)Details of Information: -

- (1) Furnish the advertisement published in which local newspaper.
- (2) Furnish the date of interview of six persons.
- (3) Furnish the date of appointment letter of six persons.
- (4) Furnish the date of joining letter of six persons.
- (5) Furnish the educational qualification of six persons.
- (6) Furnish the service record of six persons.
- (7) Furnish the record copy of promotion or regularization of six person.
- (8) Furnish the recommendation letter from MLA/Minister or any higher official against the six persons.

Brief facts emerging from the appeals:

Records emerging from the 2 appeals disclose that the Appellants herein had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to appeal before the Superintending Engineer, Coordinator (RWD), Govt. of Arunachal Pradesh, Itanagar as the First Appellate Authority (F.A.A) under Section 19 (1) of the RTI Act vide his Appeal Memo dated 01.08.2025. However, the appellant failed yet again to obtain the information and therefore, they preferred 2nd appeal before this Commission under section 19 (3) of the RTI Act. 2005 vide their Memo of appeal dt. 24.09.2025.

The above two appeals were taken up and heard together on 04.02.2026 wherein one of the Appellants namely, Shri Chungma Sangbia was present in person and the PIO was represented by Er. Shri P.D.Thangamariappan, JE with the requested documents.

This Commission after hearing the parties and upon perusing the documents brought in by the PIO's representative, had directed the Appellants to go through the documents and report shortcomings, if any within 2(two) weeks from the date of receipt of this order.

The Appellant, Shri Chungma Sangbia, in compliance with this Commission's order as above has informed vide his letter dated 09.02.2026 that the PIO had furnished the documents/information as prayed for in the Appeal No. APIC-722/2025 and that he is satisfied therewith. However, in respect of the documents/information as prayed for in Appeal No. APIC-723/2025, he had informed vide his letter dated 06.02.2026 that the PIO did not furnish the documents/information on 2 queries namely, Advertisement copy (Sl.No 1) and Date of interview (Sl.No.2) for which he has requested for hearing the said Appeal No. APIC-723/2025 again.

In the premises as above the Appeal No.APIC-722/2025 is hereby disposed of and closed and **the Appeal No.APIC-723/2025 is listed again for hearing on 06.03.2026.**

NOW THEREFORE, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on 6th March., 2026 (Friday) at 2.00 pm** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
