**WARNING SUMMON**

**WHEREAS**, in connection with the APIC-No. 196/2025, your personal appearance is required before the Commission on **19 March, 2026 at 10:30 AM**. The 2<sup>nd</sup> hearing held on 13<sup>th</sup> November' 2025 related to the APIC No-196/A/2025. The Appellant Nabam Tapak is present.

The PIO-cum-EE, (E) RWD, Poma Division, Yupia, Papumpare District, Govt. of Arunachal Pradesh found absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

**Heard the Appellant;**

The Appellant informed that the information(s) have not been provided to him by the PIO and despite of filing of first appeal before the First Appellate Authority (FAA) the Superintendent of Engineer (SE), RWC, Itanagar, who is the First Appellate Authority (FAA) did not conduct any hearing and therefore the Appellant filed the 2<sup>nd</sup> appeal before the Arunachal Pradesh Information Commission (APIC).

**After hearing the Appellant the Commission observes;**

The PIO absent for the consecutive 2<sup>nd</sup> time despite Summons being sent to be present today for the 2<sup>nd</sup> hearing, without intimating to the Commission, the reason for his inability to attend the hearing.

In the absence of the PIO the hearing could not be furthered and **the Commission hereby orders;**

1. To send Warning Summons to the PIO-cum-EE, (E) RWD, Pompa Division, Yupia, Papumpare District, Govt. of Arunachal Pradesh to be present in the next date of hearing without fail, failing which appropriate action shall be initiated against the PIO as per the provisions of RTI, Act, 2005.
2. The Appellant to be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.
3. Notice for next date of hearing be sent to the PIO.
4. Notice for next date of hearing need not be sent to the Appellant as he is present during the hearing.

**The Commission hereby orders;**

**The next date of hearing be fixed on 19<sup>th</sup> day March' 2026' at 10:30 AM (Morning).**
