The 1st hearing was held on 24th **September 2025** related to the **APIC No-213/A/2025, 228/2025, 229/2025 & 230/2025 (Appeal)**. The PIO-cum-EE(PWD), Kalaktang Division present in person but the appellant Shri Mamu Sonu found absent without any intimation to the Commission.

After going through the case record, it is seen that the First Appellate Authority has passed an order dated 20/12/2024 in which both the parties were present and the appellant was directed to collect the information from the office of the PIO-cum-EE (PWD), Kalaktang Division and intimate to the FAA within 15 (fifteen) days. If no intimation made within 15 days, the FAA will presume that the appellant has collected the information and is satisfied.

One more chance is given to the appellant to be present in person before the Commission in the next date of hearing and is also directed to collect the information from the office of the PIO on or before next date of hearing, as the PIO has stated today that required information sought is ready to be furnished. If appellant is found absent in the next date of hearing, the Commission will presume that he has collected the information and the appeal case will be heard in his absence.


