**SUMMON.**

**WHEREAS**, in connection with the **APIC-No. 608/2025**, your personal appearance is required before the Commission on 19th March, 2026 at 10:30 AM. The **1<sup>st</sup>** hearing held on **6<sup>th</sup> November'** 2025. The Appellant Shri Tamchi Gungte is absent without intimating the Commission about the reason for his inability to attend the hearing.

**Heard the PIO:**

The PIO stated before the Commission that the office of the PIO, does not have any information(s) pertaining to the information sought by the Appellant.

The PIO has already given in written to the Appellant that his office does not have any information pertaining to the application filed by the Appellant under RTI, Act, 2005.

The same reply/information was provided to the Appellant after the hearing held in the court of the First Appellate Authority (FAA) on 24<sup>th</sup> day of July' 2025 and on 30<sup>th</sup> day of July' 2025 the PIO has responded to the judgment order appeal under Section 19 (1) of RTI, Act, 2005, stating that in response to the judgment order of the FAA the PIO informed that as per office record, no such construction activities have been taken by the PIO's office.

After hearing the PIO, the statement of the PIO could not be ascertained as the Appellant is not present, and therefore, to give a fair chance of hearing to the Appellant, another date for hearing be fixed.

And therefore, the Commission hereby orders;

1. The Appellant to be present in the next date of hearing in person or through online mode without fail, failing which this instant appeal will be heard and determined ex-parte.

2. The PIO to be present in the next date of hearing in person or through online mode without fail, failing which necessary action as per the provisions of RTI, Act, 2005 will be initiated against the PIO.
3. Notice need not be issued to the PIO as he is present during the hearing before the Commission.
4. Notice for next date of the hearing be sent to the Appellant.
