ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, c/o Post Office, Naharlagun, Papum Pare District, Arunachal Pradesh for non-furnishing of information by the SPIO-cum-BDO, Govt. of A.P. CD-Block, Ziro-I, Ziro Circle, Lower Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 19/12/2022 regarding Expenditure and implementation of M-G NREGA Supply work, Ziro-I, CD Block Ziro(A.P.).

The 4th hearing is held on 27th February, 2024 as scheduled. The SPIO-cum-BDO, Govt. of A.P. Ziro-I CD-Block, Ziro, Lower Subansiri District, Arunachal Pradesh is represented by Shri Nado Dani, SO(AC). The Appellant Shri Tania June is present. During the hearing the representative of the PIO handed over a bunch of documents claimed to be the information sought by the appellant. Appellant has received the information and sought time for verification of the information so furnished. The Commission considering the appeal of the appellant granted fifteen days time for verification of the information and to intimate the commission about his findings within fifteen days from the date of issue of this order.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.



The next date of hearing is fixed on 9th April, 2024 (Tuesday) at 1030 hrs.

Therefore, the SPIO-cum-BDO, Govt. of A.P. CD-Block Ziro, Ziro-I, Lower Subansiri District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
