**ORDER/SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Director of TRIHMS Naharlagun (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 04.09.25:

**A. Particular of information:** c/o "Establishment of New Medical college attached with District/ Referral Hospitals (Tomo Riba Institute of Health & Medical Science, Naharlagun". From the financial year 2017-2018 to till date.

**B. Details of information required:**

1. Furnish the certified copy of total Fund allocation received (with proper proof of documents) from the concern Ministry of govt. of India (Central Share) and the Govt. of (state share) from the initial stage of execution of the project to till date.
2. Furnish the certified copy of total amount of UC submitted by the Director TRIHMS to the concern ministry and the state Govt. in respect of the project mentioned above from the initial stage of execution of the project to till date.
3. Furnish the certified Notice Inviting Tender copy of the fund released apart from 189 crores in respect of the project mentioned above.
4. Furnish the certified payment details (in cheque counterfoil, PFMS slip etc. whichever method is used) of the fund released apart from 189 crores in respect of project mentioned above.

This appeal was heard on 24.04.2026 wherein the appellant was present in person while the PIO was represented by Shri Toba Karga, Project Supervisor, TRIHMS.

The representative of the PIO, submitted that the appellant has requested the PIO similar information/documents in an another appeal pending before one of the co-ordinate court of this Commission and as such the requested documents were not furnished to the appellant. He also submitted that since the requested information such as the funding pattern of the construction of the TRIHMS, share of Central and State Govt. etc. are financial in nature, it will be appropriate that the Finance & Accounts Section of the TRIHMS is heard for proper replies/information.

This Commission, upon hearing the parties, directed the PIO to furnish the requested information which are found not exempted under any of the exemption clauses of section 8(1) of the RTI Act, 2005 at right earnest and report the compliance therewith on **29.05.2026**, the next date of hearing.

As suggested by the representative of the PIO, the in-charge of the Finance & Accounts section of the TRIHMS was also directed to be present along with the PIO in the hearing for clarification, required if any, during the hearing.

Today on 29.05.2026, the PIO did not appear who, however, informed vide his letter dt.29.05.26, that due to his pre-occupation in the ongoing inspection of the TRIHMS by the National Board of Examination in Medical Science (NBEMS), he will not be able to attend the hearing. However, the Finance & Accounts Officer of the TRIHMS ought to have attended the hearing as directed.

In the premises as above, the hearing is adjourned to 08.06.26 at 2 pm wherein the PIO must be present with the in-charge of the accounts section as directed earlier failing which penal action under section 20 of the RTI act shall be invoked against him.

**NOW THEREFORE**, the PIO is hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person on 8<sup>th</sup> June, 2026 (Monday) at 2 PM to answer the claims, and you are directed to produced on that day all the documents upon which you intend to rely in support of your claims / defence.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
