**SUMMON.**

The 5<sup>th</sup> hearing held on 8<sup>th</sup> April, 2025 related to the APIC No-178/2024. The Appellant Shri Pate Mesi Lomdak found absent without intimation the Commission reason for his inability to attend the hearing. The PIO-cum-EE, (E), Electrical Circle-V, Department of Power, Ziro, A.P, is present through online mode during the hearing before the Commission.

**Heard the PIO:**

The PIO stated before the Commission that all the information(s) have been furnished to the Appellant through post and also through WhatsApp on 28.03.2025, and received by the Appellant. He further informed the Commission that he has communicated to the Appellant about the information(s) sent and the receipt of the same, has been acknowledged to him by the Appellant.

The Commission observes;

The receipt of the information(s) by the Appellant could not be convincingly presented by the PIO, hence, the Commission could not be convinced enough to dispose this instant appeal.

**The Commission hereby orders;**

- (i) The PIO to ascertain the receipt of the information(s) by the Appellant on or before the next date of hearing.
- (ii) Notice need not be issued to the PIO, as he is present during the hearing before the Commission.

- (iii) Notice be issued to the Appellant to be present in the next date of hearing to ascertain the receipt of the information(s) from the PIO, on or before the next date of hearing, failing which this instant appeal will be heard ex-parte.
