## ARUNACHAL PRADESH INFORMATION COMMISSION

### ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Kimin Ingo for non-furnishing of below mentioned information by the PIO, o/o the Circle Officer, Sangdupota Circle District Papum Pare A.P as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 02.09.2025:

**A) Particular of Information:** Regarding Land possession certificate (LPC) copy of

- Shri Pango Gango Located Jote-II Village.

### **B) Details of Information required**

- 1) Furnish the certified copy of the Land gift deed/ Land sale deed/ Agreement letter made between Shei Nabam Sanjay of Jote-II village and on Shri Pango Gango.
  - 2) Furnish the certified copy of the Land possession certificate Form submitted by Shri Pango Gango to the C.O Sangdupota along with all the relevant document i.e (i) ST (ii) PRC (iii) pass photo copy (iv) Voter ID card (v) Aadhar Card (vi) Electricity bill/ Water bill.
  - 3) Furnish the certified copy of the sketch map copy.
- C) Period for which information asked for: 2025.

### **Brief facts emerging from the appeal:**

Records in the appeal revealed that the appellant had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month which prompted him to file appeal before the First Appellate Authority (FAA), the Additional Deputy Commissioner, Govt. of A.P, Balijan under section 19(1) of the RTI Act vide Memo of Appeal dt. 19.09.2025. But having failed yet again to obtain the information, he preferred his 2<sup>nd</sup> Appeal before this Commission under section 19(3) of the RTI Act vide Appeal Memo dt. 06.11.2025.

This appeal was, accordingly, listed and heard on 20.03.2026 wherein the appellant, Shri Nabam Tangum was present in person but the PIO was absent.

This Commission, upon hearing the appellant and on perusal of the records in the appeal, noticed that this appeal was not heard/considered by the Additional Deputy Commissioner, Govt. of A.P, Balijan under section 19(1) of the RTI Act, 2005. And as such this appeal was remanded to the FAA vide Commission's order dt.20.03.2026 for adjudication and passing an appropriate order as mandated under section 19(1) within 4(four) weeks from the date of receipt of the said order with liberty to the appellant to prefer second appeal before this Commission, if dissatisfied or aggrieved by the decision of the First Appellate Authority.

It now transpires from the letter dt.11.05.2026 received from the appellant, Shri Nabam Tangum that the FAA, the ADC, Balijan did not conduct the hearing of this appeal making the appellant approach this Commission again in terms of the liberty granted to him. The extract of the appellant's letter dt.11.05.2026 is reproduced hereunder:

*I respectfully submit that I had filed an RTI under the right to information act Act, 2005 before the public information officer (PIO) seeking certain information. As non information was provided within the prescribed time limited, I subsequently filed a First Appellate Authority (FAA) However, till date neither the requested information/documents was furnish from the PIO nor any order from the First Appellate Authority has been received or given me so far.*

*The non-response from the concerned authorities is a violation of the provision of RTI Act, 2005. Therefore; I humbly request the Hon'ble commission to kindly take cognizance of the matter and pass appropriate directions to the concerned authorities for providing the request information.*
