**WARNING SUMMON**

**WHEREAS**, in connection with the **APIC-No. 153/2025**, your personal appearance is required before the Commission on **15<sup>th</sup> JANUARY 2026 at 01:30 PM**. The 2<sup>nd</sup> hearing held on **18<sup>th</sup> September, 2025**. The Appellant Shri Mamu Sono is present during the hearing before the Commission.

The PIO-cum-Executive Engineer, PWD, Bomdila Division, West Kameng District, Govt. of Arunachal Pradesh found, absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

After hearing the Appellant: the Commission observes;

The PIO absent for the 2<sup>nd</sup> consecutive time wherein the PIO absented in the first hearing also which took place on 10<sup>th</sup> June' 2025 for which absence of the PIO the Commission took serious note and issued summons to the PIO to appear today without fail, but despite of issuance of summons the PIO has failed to turn up for hearing today which is the 2<sup>nd</sup> hearing.

Viewing seriously the absence of the PIO the Commission hereby orders;

- i) To issue Warning Summons to the PIO to appear in person or through online mode before the Commission in the next 3<sup>rd</sup> hearing without fail, failing which strict action as provided under the provisions of RTI, Act, 2005 shall be initiated against the PIO.
- ii) The PIO to furnish all the information(s) to the Appellant.
- iii) The Appellant to be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.
- iv) Notice need not be issued to the Appellant as he is present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 15<sup>th</sup> January, 2025' at 10:30 AM (Morning).
