SUMMON NOTICE.

The 5th hearing was held on 11th March, 2026 related to the APIC No-357/A/2025(Appeal). Appellant Shri Taram Kenji, Nangram Ganesh and Gichik Toper Kiogi attended the hearing through VC and the PIO-cum-Director, Elementary Education present in person.

PIO stated before the Commission today that the information sought by the appellant has been furnish from the concerned 8 (eight) DDSE : (1) Papum Pare, (2) Itanagar Capital Region, (3) Lower Dibang Valley, (4) Lohit, (5) Tirap, (6) East Siang, (7) Upper Subansiri and (8) Lower Siang. The PIO has brought the information provided by 8 DDSE today but could not handed over to the appellant as he is present through VC. Appellant is directed to collect the information from the PIO and intimate to the Commission within 15 (fifteen) days.

The PIO also stated that reminder letter was sent to all the DDSEs to furnish the information as per the Form A application of the appellant. But only (eight) DDSEs responded.

The DDSE, Itanagar Capital Region has replied that the information sought covered under Section 8 (1) (j) of the RTI Act and refused to furnish the information.

The Commission is of the view that the information sought is in the larger public interest so the information sought as per Form 'A' should be furnished by the concerned department.

Last chance is given to the DDSE to furnish the information and if fails to do so, the concerned DDSEs will be made as PIO directly as per Sec. 5 (5) given under RTI Act.

The Commission adjourned the hearing and fixed next date on **4/5/2026 at 1030 hours.**
