ORDER.

The 8th hearing was held on 3rd February, 2025 related to the APIC No-12/2024(Appeal). Appellant Shri Bini Toluk present in the hearing but the PIO-cum-Executive Engineer (PWD), Raga Division found absent without any intimation to the Commission.

That Penalty amount of Rs. 25,000/- (Rupees twenty five thousand) only was imposed against the PIO for non-compliance of the Commission's order. The PIO was also directed to compensate the appellant a sum of Rs. 5,000/- (Rupees five thousand) only for monetary loss incurred during to & fro journey expenses.

It is seen from the case record that the PIO is reluctant to appear before the Commission and has will fully disobeyed the order of the Commission in spite of giving repeated summons. The PIO has failed to deposit the Penalty imposed inspite of giving notice for the last two consecutive times dated 3rd February, 2025 and 17th March, 2025.

The Commission hereby gives last chance to the PIO to be present before the Commission and deposit the Penalty amount of Rs. 25,000/- into the **Head of Account "0070" address to the Registrar, State Information Commission** before the next date of hearing.

If the PIO fails to obey the order, the Commission will be compelled to recommend for disciplinary action under Section 20(2) of the RTI Act as per the Service Rules as applicable.

The Commission fixed next date of hearing on **09/06/2025 at 1030 hours.**
