ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Miss Bengia Mama for non-furnishing of below mentioned information by the PIO, o/o the (APB&OCWWB), Itanagar as sought for by her under section 6(1) (Form-A) of RTI Act, 2005 vide her application dated 15.05.2025.

Facts emerging from the appeal:

Records reveal that the Appellant, Ms. Bengia Mama had asked for the above mentioned information from the PIO vide her application dated 15/09/25 before the PIO o/o the Arunachal Pradesh Building & Other Construction Workers Welfare Board (APB&OCWWB), Itanagar but could not obtain the same which prompted her to approach the Secretary cum First Appellate Authority, APB&OCWWB, Itanagar under section 19 (1) of the RTI Act. 2205.

But the appellant, apparently, failed to obtain the information yet again and as such she filed her 2nd Appeal before this Commission under section 19 (3) of the RTI Act vide her Memo of Appeal dt. 16.12.2025.

This appeal has, accordingly, been registered in this Commission as APIC 911/2025 and listed for hearing today on 06.05.2026 wherein the PIO, Shri Konu Pordung, R.O appeared through VC but the appellant is absent who, vide letter dt.04.05.2026, informed that due to her scheduled examination at Himalayan University, she will not be able to attend the hearing and requested for adjournment of the hearing.

This Commission considered the request of the appellant and adjourns the hearing of this appeal to 24.06.2026. Meantime, the PIO is directed to furnish the requested information which is found not exempted under any of the exemption clauses of section 8 of the RTI Act, 2005. It is, however, made clear that as required under section -7(8)(i) of the RTI Act, when an information is denied to the applicant, the reason thereof has to be communicated to the applicant to his/her satisfaction. And as mandated by section-18(3)(c) of the RTI Act and rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005, the submission/reply of the PIO has to be furnished by way of an affidavit. The PIO is, therefore, directed to furnish appropriate replies and /or affidavit against the information/replies which his office does not hold within 45 (forty five) days and report compliance thereof on 24.06.2026, the next date of hearing.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
