**SUMMON NOTICE.**

**The 2<sup>nd</sup> hearing was held on 8<sup>th</sup> December, 2025** related to the APIC No-567/A/2025(Appeal). PIO-cum-CSQ, O/o Chief Engineer (PWD), is represented by Er. Bompi Bam, AE and the appellant Shri Rajesh Paron attended the hearing through VC.

PIO stated that they have sent notice to Third Parties twice but no response received from the Third Parties except one M/s T. M. Enterprises.
