**WARNING SUMMON**

**WHEREAS**, in connection with the **APIC-No. 132/2025**, your personal appearance is required before the Commission on **10<sup>th</sup> February, 2026 at 01:30 PM**. The **2<sup>nd</sup>** hearing held on **14<sup>th</sup> October' 2025**, related to the **APIC No-132/2025** (Appeal). The Appellant Shri Tai Patum, found absent during the hearing without intimating the reason for his inability to attend the hearing.

The PIO -cum Deputy Director of School Education (DDSE) Upper Subansiri District, Govt of Arunachal Pradesh is also absent without intimating to the Commission the reason for his inability to attend the hearing which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides public duties also has to attend Court hearing when as appeal is preferred against him as per the provision of the RTI Act 2005, which is statutory duty binding upon the PIO.

**The Commission seriously viewed the absence of both the parties and hereby orders;**

- i) To **Summon** the PIO-cum-Deputy Director of School Education (DDSE) Upper Subansiri District, Govt. of Arunachal Pradesh to attend the hearing on the next date of hearing without fail, **failing which necessary action as provided by the RTI, Act, 2005 shall be instituted against the PIO.**
- ii) The PIO to provide all the information(s) sought by the Appellant, which are available in the office of the PIO on or before the next date of hearing.
- iii) To **Summon** to the Appellant to be present on the next date of hearing, **failing which the instant appeal shall be heard and determined, ex-parte.**
- iv) **Due to absence of both the parties, the Commission could not proceed the hearing of the appeal.**

**The Commission hereby orders;**

**The next date of hearing be fixed on 10<sup>th</sup> Feb' 2026' at 1:30 PM (Evening)**
